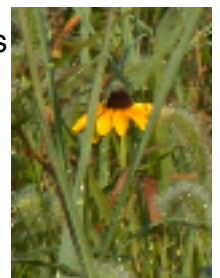

# Member Hikes for Fulton County Trail Sections

Member Paul Zumfelde recently proposed to Jay Budde that he would like to hike border-to-border in Fulton County on the Wabash Cannonball Trail. In fact, Paul has already hiked much of the trail but his additional idea now is to photographically document the trail, including road crossings, scenic areas and other key trail features in Fulton County sections. These photos will be used to create or update maps and possibly to create a Google map for trail access and reference when planning to use the trail. The border-to-border aspect of the hikes will be accomplished by a number of short 7 day hikes.

The first trail section Paul and Jay plan to hike and photograph is Fulton Co. Road 16 to 20. This section will be hiked in August. Future 4 – 5 mile trail sections will be hiked and photographed this fall. A tentative second trail section hike (location yet to be determined) is planned for Wednesday, October 5, 2011.

The following article was submitted by Ed Snyder from his family newsletter "Snyde Comments". It was written by Mary Ivory, Ed's sister and member of NORTA. It is good to see what a nearby Rails-to-Trails organization is doing.

Rails to Trails: There are rails-to-trails from Clyde going West and from Elyria coming East all the way past Steve's work in Monroeville. Last year, the Firelands' Rails to Trails organization (headquartered near Steve's work) started working on the trail West of Monroeville heading to Bellevue. They got to Route 4 before weather became uncooperative and they waited to finish until this past spring. Steve and I decided we should volunteer at one of the group's Saturday work days-so we did, and we "dragged" Danny with us. (Afterwards, Danny said it "wasn't so bad-it was actually fun.")

For our first work day, we drove to Monroeville to the Firelands Rails to Trails headquarters, the Monroeville Depot. On the way, we were discussing what projects they might be working on that day. Steve said "as long as we didn't have to paint", (we weren't dressed for painting), he was up for practically anything. When we arrived, the other volunteers seemed surprised. It's been a while, I think, since they got new volunteers. They didn't know what to have us do, "unless you want to help put the second coat of paint" on the depot. So we got brushes and a ladder and did some painting. It wasn't bad at all. Since we used brushes at the depot, there was not a lot of mess. When the other volunteers were done with their work, they started painting too, so by noon the entire north side of the depot had a second coat. Only the West side of the depot is completely finished with new paint, windows and trim. There is still a lot of work to do on the remaining two sides along with finishing a "porch" on the front.

A couple weeks later, Steve had to do some work and Danny and I went to the depot to volunteer again. This time we helped put together sign posts and mile markers for the trail. A couple weeks later, Steve, Danny and I drove to Collins (west of Norwalk) and helped install signs and helped with some clearing. I took some pictures of the volunteers so I could send it to our local newspaper. I was hoping that it would help attract more volunteers from Bellevue. They actually put my two pictures, which included Danny and Steve and the other volunteers, along with details of our Saturday workday. A week later, the three of us were working on the trail in Bellevue putting up the signs and mile markers that Danny and I had put together. The president of the Rails to Trails organization had his camera this time and he took a picture of all of us holding a big sign that read "Welcome Bellevue, We made it!" He sent the picture out with a press release and it made it into our paper the next week.

At the last Rails to Trails monthly meeting it was noted that one of their goals was to gain 2 members from Bellevue. Since there are the three of us helping now, they were excited to exceed their goal! The trail has reached Bellevue from the East, but then hits a dead end. Our recreation department in town and the city department are working on directing trail traffic to our recreation center by city roads and then through our town until hitting the west side of town where Sandusky County will assist in getting the trail to meet up with the Clyde trail. 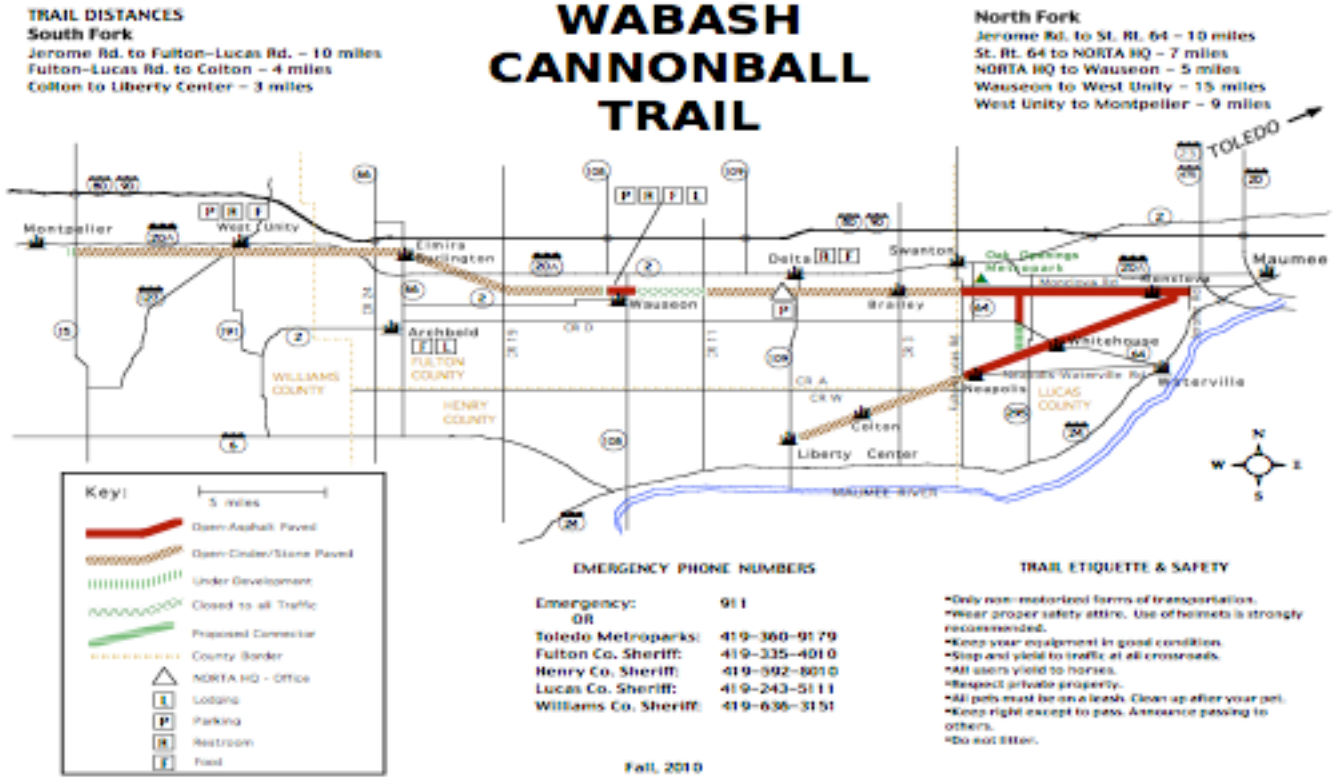
# My Favorite Mile -Fulton County Road 20 to 21

One of the beautiful, wooded sections of the Wabash Cannonball Trail, which my wife and I love to hike throughout the year is between Fulton Co. Roads 20 and 21. We love the variety of environments and views you encounter at different seasons: cultivated farm fields, hardwood forest, spring pools with singing tree frogs, wildflowers. We hike this section in all seasons.

Winter X-country skiing this section is also a thrill with wind-sculpted drifts in a middle of this mile often looking more like the arctic than NW Ohio. The old hilltop cemetery of some long gone Eckley church, one of the "ghost towns" of the trail, makes for an interesting side stroll at the East end to this mile.

There is easy parking at either the East (Road 20) or the West ends. You will want to avoid the summer mosquito months, but in spring, winter and fall this favorite mile is a treat.
